



“COMEDY CENTRAL WIN A TRIP TO LONDON COMPETITION” COMPETITION RULES AND REGULATIONS

1. “Comedy Central Win a Trip to London Competition” (the “Competition”) will run from Monday 13 May 2019 at 00:00 CAT until 2 June 2019 23:59 CAT.

3. To be eligible (the "Eligibility Requirements") to enter, entrants must:
 - a. 18 years old as of 13 May 2019;
 - b. be a resident of South Africa;
 - c. possess a valid passport (accompanying travel partner must also hold a valid passport). Passports must qualify with all requirements under an entrant’s local law;
 - d. possess a current UK visa, **or be eligible to successfully apply for a UK visa** (accompanying travel partners must also hold a current UK visa or be eligible to successfully apply for a UK visa); and
 - e. be available to travel to the UK between 28 June 2019 and 14 July 2019. Departure and return dates will be confirmed with the winner.
4. To stand a chance of winning, entrants must snap the various British Symbols that are broadcast on Comedy Central DStv Channel 122 and WhatsApp the snaps to **081 505 0282**.
 - Each day different British Symbols will be broadcasted and will **not** be the same as the day before.
 - A maximum of 2 British Symbols will be broadcast per day. Therefore, entrants can submit a maximum of 2 valid entries per day.
 - Snaps must be from the day the British symbol/s was broadcast. Snaps from any other day will not be considered as entries.

 - e. Ground Transport / transfers to and from *activities (*activities TBC)
